



# **STATEMENT:**

I am honored to have been nominated for a position on the Vestry of St Luke in the Fields. Like many of you, I did not grow up in the Episcopal Church, but felt immediately drawn to its governing structures by lay members and clergy alike. And once I found it – or rather, it found me – one of the great attractors affecting my decision was our history and commitment to lay people being an integral part of the life of the Church, and not simply by sitting in the pews and making a pledge. Each order has its place and responsibilities - Clergy, of course, are in charge of liturgy, outreach and pastoral issues, but your Wardens and Vestry are responsible for the other parts of keeping St. Luke's a community – finances,

property and grounds upkeep and improvements, and all the other needs of running any organization. I often tell people simply to think of the Wardens and Vestry as a Board of Directors for the parish.

This year of course has been an exercise in adjustment and many difficult challenges, new policies and procedures, patience and most important, the fact we have not been able to be with each for worship and other activities. As the Recording Secretary for the Vestry, I have seen up close how our leaders, Clergy and Vestry, have worked diligently to adjust to these major challenges posed by COVID-19 to our life together. (The Recording Secretary is responsible for the minutes of meetings, so I attend every Vestry meeting, but have no vote.)

What is certain is that the pandemic will end, but we will return to a St. Luke's that is not the same as before. And each of us will be changed in some form, both as individuals and in community. The challenges to the new Wardens and Vestry are to put in place policies that will protect the health and well-being of all of us. We have answered the call to aid those in need during this extraordinary period with our mobile feeding program. St. Luke's will not be the same parish as before, but I believe that after coming through this challenging time, our community will be stronger and closer than ever. Your Wardens and Vestry will be faced with many challenges, and I hope you will consider giving me the opportunity to join them as we face the future working on our ultimate goal – proclaiming the Gospel of Jesus Christ by being a Beloved Community which puts our belief in that Gospel into action for all to witness.

Some personal notes: I have been at St. Luke in the Fields for about nine years, having previously been a congregant at a very small Episcopal parish in Northern Manhattan, where I live. While there I served in many capacities, including as a Warden and a Vestry member. I would bring some experience in what those positions involve, albeit on a much different scale.

Here at St. Luke's I've been privileged to serve in a number of capacities – for the Acolytes Guild, as assistant guild head, working with Mary O'Shaughnessy on scheduling and training new members of the guild. I am also on the Altar Guild, working to set up for worship on Sundays and weekdays. (Many Sundays when I am on duty, you will find me in the Sacristy ironing the linens used for services. I've found that this simple task provides a time of reflection and peace. It has truly been a difficult adjustment for me not to be able to do this simple service.) Previously I was on the Nominating Committee, and have been on the Stewardship Committee for a number of years. Also, it has been my privilege to have been a Delegate to our Diocesan Convention these past few years; this is where we get to see the Episcopal Church's protocols for governance up close and in action.

I hope you will give my candidacy prayerful consideration and vote for me. It will be my privilege to serve our wonderful faith community.

#### **STATEMENT:**

Being the wife of an academic, I've lived in several different places, all of them far from my place of origin in the south, first in Auburn, AL

where I was born and baptized at Holy Trinity Episcopal Church, and then in Raleigh, NC, where I grew up going to several Episcopal churches at different points in my younger life.

After marrying my husband Rob, we moved from Chapel Hill, NC to Williams, MA, then to New Haven, CT, where I gave birth to our son Amos, then to Portland, OR and now to Manhattan. At each of these locations, I sought a church home and quickly found out how important that was for me because the Episcopal Church, with its familiar liturgy and order, always grounds me, no matter how far from home I may be.

I've been a member at St. Luke in the Fields since we moved here ten years ago. My previous church journeying helped me to find it, as it was recommended to me by the Rev. Peter Elvin, who was Rector at St. John's Episcopal Church in Williamstown when we lived there and who played a significant role in my spiritual life and who, along with his wife, is still a friend. (Incidentally, Peter also lead me to The Episcopal Church of St. Paul and St. James in New Haven, which was a wonderful parish where I was active in the Food Pantry as coordinator and where our son Amos was baptized!)

I have put energy, time and faith into St. Luke in the Fields for the last 10 years and I feel I can serve it, prayerfully, along with fellow vestry members, some of whom surely have more business and financial experience than I, in a good and humble way.

# LESLIE EVANS


OCCUPATION: Attorney (retired from a Federal agency)
